Financials: Clair (15 minutes) – transferred \$5000 to cover electric bill, all CDs went into Money market, need to reinvest into new CDs but wants to keep at lower amounts, like \$10K, in case the money is needed before maturity. All accounts are reconciled. Appointments next week to see about new bank due to M&T fees. Should we be reimbursing the Homeowner's if over charging for fees? Sometimes it's 0.50 over sometimes exact. Annual franchise tax filed yesterday. Paid for snow-removal and filed for reimbursement from DelDot. Mike put his cc on file for website renewal. Double charge for Qbooks, they will be reimbursing within 7-10 business days. She will get better about getting all the memos entered so we all know what's what. Learning-curve for software. Hoping the removal of the 3 streetlights will reduce the Delmarva Power bill (~\$1100/mo)

**Stop Sign Bars**: Dan (10 minutes) - clarification of the distributed document and map, consensus for further activity. Started with DelDot – no action. Reached out to Rep Collins office – more helpful, they're looking into what they can do and what's available in their CTF (community traffic fund). Dan wants us to do it, suggested 10 spots. Worst spot is Shawnee/Hiawatha intersection, then Chippewa/Hiawatha intersection, and

Shawnee/Feather intersection. Maybe get quote from company that paints parking lots after hear back from Rep's office. Dan will let us know when/if he hears something.

Pier Repair Status: Dan (10 minutes) - develop strategy to achieve pier improvement

John Merit was consulted once re this, but no action was taken. John was reaching out to Parks Department but nothing. DNREC approved work done previously. Dan will reach out to DNREC to see what's what. Need to create a committee to determine what to do and how to do it, and who needs to approve it. Dan and Bob are interested in being involved, Mike mentioned Lou would also be interested. Repairs don't need to be approved, but improvements/changes need to be approved. Shawnee needs to be raised at the end.

- Immediate actions repair to make safe, replace missing pieces and rotting wood
- Subsequent actions improvements like raising or widening or adding additional supports

Mike will reach out to Lou, Tom, and Bob to gauge interest. Need to look into financing to see if there is an interest-free loan or something we could use.

Clair reached out to John Kane – used to be the environmental attache to Carper, he will look into and see what's out there, but DNREC will be the backlog as permits are taking 6-12 months for approval. MK will ask Jordan regarding process and costs for this type of work.

**Survey Initiative**: Patti (5 minutes) – obtaining requests from the board for an upcoming survey we will be conducting

Sewer survey was very successful. Want to do it again to gauge the pulse of the community. Each board member will think of a few potential questions for the survey for the next meeting. Potential topics: events, improvements, dumpsters
